Dear Hydrographer,

1. Under the terms of Reference A and in accordance with the IHO Work Programme for 2015 approved by the 5th Extraordinary International Hydrographic Conference (Reference B), the 8th Biennial Conference organized by the Advisory Board on the Law of the Sea (ABLOS) will be held in Monaco from 20 to 22 October 2015. The theme for the 8th ABLOS Conference is:

“UNCLOS: Advances in Governing the Blue World”

2. The Directing Committee is pleased to note that, again this year, the ABLOS Conference is being organised in association with the *Institut du Droit Économique de la Mer* (INDEMER) of Monaco through the good offices of Madame Annick de Marffy-Mantuano, President of the Scientific Council of INDEMER and a former Director of the United Nations Division for Ocean Affairs and the Law of the Sea (DOALOS).

3. Previous ABLOS Conferences have always been oversubscribed. For this reason, the 8th Conference will be held at the Novotel Hotel in Monaco. This venue will accommodate up to 120 delegates, a much greater number of participants than could be seated at the IHB. Registrations will be accepted with full payment of fees on a first come, first served basis.

4. A publicity leaflet is forwarded with this letter. The ABLOS would be grateful if it is distributed within your organization and brought to the attention of other relevant national authorities and educational institutions.

morning and afternoon refreshments, lunches and an official evening reception. The registration fee will be waived for students who are accepted to deliver presentations.

7. A block booking of 100 rooms has been made at the Novotel at a special conference rate including breakfast of 155 Euros for a city view room and 165 Euros for a garden view room.
