

Background information	During the CPRNW10 meeting the interest on IHO MSI Capacity Building Course was discussed by NAVAREA V and NAVAREA VI coordinators. They informally agreed that it would be an excellent opportunity to countries under SWAtHC influence acquire and share the knowledge of good procedures to make and control Maritime Safety Information – MSI, following the IHO/IMO resolutions and PRNW orientation. This course has already been carried out in other Regional Hydrographic Commissions.
Justification of the project	This course would permit the NAVAREA V and VI coordinators improve their operational procedures and know which corrections should be make to put in the right and optimal manners the World-Wide Navigational Warnings Service – WWNWS, as well the effective coordination of the NAVAREA itself.
Countries involved	SWAtHC members and others South American countries interested. In addition, the course would be opened to outside observers from other countries.

Exposition of the problem	NAVAREA Coordinators has been looking for possible corrections and has been doing efforts to comply their promulgation of radio navigational warnings to the international rules, as well motivate his staff to maintain the proficiency already reached. With this course, SWAtHC members and other countries in South America will have the opportunity to exchange their experiences and enhance their knowledge about this issue.
General objective	To increase the capacity of the SWAtHC members and other countries in South America to properly meet the IHO/IMO standards related to MSI promulgation.
Specific objectives	To improve the proceedings of control and promulgation of MSI via serviço SafetyNET/NAVTEX.
Outputs/Products	More qualified teams for WWNWS and MSI promulgation and, consequently, improvement of the safe navigation practices into Southwest Atlantic maritime area.
Other deliverables	Enhance the regional NAVAREA coordinators` interaction to solve common problems; More hydrographers aware about IHO/IMO and CPRNW requirements.
Achievements and awaited benefits	Qualified teams so as to provide better MSI, resulting in a great support to safe navigation.
Schedule of activities	Details of course topics and the schedules of daily activities will be provided after discussed

with the PRNW Chairman.
