Introduction

1. WWNWS3 placed an action item on the Document review WG to consider the inclusion of suitable text in the WWNWS documentation to provide guidance on how NAVAREA Co-ordinators provide information on "In Force" messages.

Discussion

- 2. Significant progress has been noted over the past few years in respect to In-force Bulletins, not least the issue of how to provide mariners with information on how to obtain the full text of those NAVAREA Warnings which are no longer being transmitted after 6 weeks (WWNWS3/4/2B refers). Nonetheless, some NAVAREA Co-ordinators have still failed to grasp the concept that these In-force Bulletins should be part of their numbered series of NAVAREA Warnings and should remain in force for 1 week, until cancelled by the next bulletin, unless there are "No Warnings in force", which is catered for by a separate message.
- 3. It may be helpful to begin by reminding ourselves of the relevant extracts from the related documents referenced above:

2. DEFINITIONS

- **2.1** For the purposes of the WWNWS, the following definitions apply:
- **.4** In force bulletin means a list of serial numbers of those NAVAREA, Sub-Area or coastal warnings in force issued and broadcast by the NAVAREA coordinator, Sub-Area coordinator or National coordinator during at least the previous six weeks.

.15 NAVAREA warning means a navigational warning or In-force Bulletin promulgated as part of a numbered series by a NAVAREA coordinator.

6.2 NAVAREA coordinator responsibilities

6.2.1 The NAVAREA coordinator must:

.7 ensure that NAVAREA warnings which may remain in force for more than six weeks are made available immediately to NAVAREA coordinators, other authorities and mariners in general, as appropriate;

- .9 broadcast In-force Bulletins not less than once per week at a regularly scheduled time;
- 4. The following examples in Annex A of this paper highlight the differing interpretations amongst NAVAREA Co-ordinators to the guidance contained in paragraph 3 above. These examples have been produced using only the information available on the individual web sites of each NAVAREA Co-ordinator and it is therefore conceded that it is possible that some In-force Bulletins may be broadcast on SafetyNET but not reproduced in the internet.

Action requested of the Sub-Committee

- 5. The Sub-Committee is invited to:
 - a. Instruct the Document review WG to prepare further explanatory notes for inclusion in the Joint IMO/IHO/WMO Manual on Maritime Safety Information, in Chapter 7, section BULLETINS.
 - b. Remind all NAVAREA Co-ordinators of the importance to strive for consistency in the interpretations of the guidance documents and recommend that as a minimum, the following points are considered in respect to In-force Bulletins:
 - i. They should be part of the numbered NAVAREA Warning series, and be issued via SafetyNET as an individual numbered message which remains in force for one week.
 - ii. Each bulletin should include the DTG of when it was prepared,
 - iii. It is recommended to list ALL messages still in force, not just those issued within the past 6 weeks,
 - iv. It is recommended to include details of where mariners can obtain copies of those messages which remain in force, but are no longer being broadcast, as they are more than 6 weeks old.
