Dear Colleagues,

Subject: 4th CSPCWG Meeting, 13-15 November 2007, Monaco

You will recall that at our last meeting, CSPCWG 3, we agreed that the next meeting should be in week 46 of 2007 (week commencing 12 November). We also noted that, because of the difficulty in completing the agenda, it may be necessary to increase the duration to three full days. As we have already noted a significant number of items for this meeting, and experience suggests more items will be offered in the lead up to the meeting, we have planned for three full days: Tuesday 13 to Thursday 15 November.

Netherlands are unable to host the meeting in the week following the CHRIS 19 meeting in Rotterdam. CSPCWG 4 will therefore be held in Monaco, which is easy to access for those members who are already in Europe for the CHRIS or its associated meetings.
