REVIEW OF IHO PUBLICATION M-3 TECHNICAL AND ADMINISTRATIVE RESOLUTIONS OF THE IHO

Dear Chairman,

1 The XVIIth IHC approved the IHO Work Programme for the period 2008 – 2012 which included an item under Task 4.1.3 to prepare, with the support of IHO bodies, a new edition of M-3, the "IHO Technical and Administrative Resolutions".

2 The IHB has reviewed M-3 and identified those relevant Committees for the review of specific resolutions. In the case of CHRIS and the GEBCO Guiding Committee, the IHB has also identified the subsidiary bodies that could carry out the detailed review. Other resolutions of a more general nature will be reviewed by the IHB.

3 In the annex to this letter you will find a list of those resolutions which the IHB considers relevant to your committee. Following the title of the resolution you will find suggestions from the IHB as to the action which might be considered appropriate. These suggestions are in red text and include "OK", "delete", "review" and in some cases a suggested revised text is provided. Marked in blue is the relevant body as suggested by the IHB.

4 You are requested to review the resolutions in the annex and provide proposals to the IHB as appropriate by December 2008. The IHB will then submit the proposals to Member States for adoption. Once this process has been completed the IHB will consider a restructuring of M-3 in order to make it a useful document.
