Re-Survey MWG Report to the BSHC 24th **Conference in Gdansk, Poland**

1. Status of the work of Re-Survey MWG since BSHC 23rd Conference, Aalborg

Mr. Seppo H Mäkinen [FI] has acted as the Chair. There is no permanent secretary for the MWG. Lars Hansen [DK] acted as the secretary of the MWG 18th meeting and Jean-Guy Nistad [DE] for the 19th meeting. All the BSHC countries have nominated members to the working group, however not all have been active or participated to the meetings.

The main tasks for the MWG has been to continue the development of the Re-Survey database and to encourage the member states to continue the up-to-date surveys of their waters.

The communication within the MWG has been by MWG Letters and e-mails.

2. Monitoring Working Group meetings

MWG 18th meeting 27 August 2018 at GST, Aalborg, Danmark

The meeting was held right before BSHC23 conference. The main subject was to go through and discuss the BSHC23 MWG report and to discuss the IHO S-44 PT (HSPT) work.

- The status of the MS HELCOM re-surveys in Re-survey Database was also • reviewed in conjunction with EU CEF funded FAMOS Odin project.
- The IHO S-44 ed 5 renewal scoping project team members Anders Åkerberg and • Hans Öiås [SE] briefed on team's work.
- The task 1.7 to support IHO working groups and other European projects in issues concerning IHO S-44 and survey status was approved at BSHC22. Otherwise TORs of the MWG and the Work Programme for the years 2016-20 were found accurate. Upcoming meetings were listed in which MWG work is presented.
- Mr. Seppo Mäkinen [FI] opened the chair and vice-chair positions. No candidates for either position. Seppo Mäkinen [FI] will continue for the time being.

MWG 18 B meeting and S-44 HSPT regional discussion group workshop was held on 14-15 November 2018 at Maritime Administration of Latvia, Riga, Latvia

A combined workshop and meeting was held in order to discuss the work of the S-44 HSPT and to bring the BSHC perspective. The BSHC member states participants of the HSPT took note of the lively discussion for the preparation of S-44 ed 6.

- A regional S-44 PT regional discussion took place and the work of the IHO S-44 HSPT was discussed thoroughly by the participants.
- Re-survey progress was presented by attending members and Re-Survey DB viewed online. Progress has taken place.
- Upcoming activities were listed.



MWG 19th meeting 16-17 April 2019 at Eesti Veeteede Amet, Tallinn, Estonia

The meeting concentrated to discuss the following

- IHO S-44 PT (HSPT) work, based on S-44 ed 6 draft 1.5.1. widely explained by Jean-Guy Nistad [DE] and Hans Öiås [SE]
- to prepare the BSHC24 MWG report
- to prepare the HELCOM re-survey scheme assessment;
- to prepare a proposal to BSHC24 of a possible continuation of HELCOM Resurvey Scheme containing Cat III areas.
- LT, PL and RU should discuss the CAT I & II areas in the South-Eastern corner of the Baltic Sea. There are clear discontinuations in the Fairway areas on the border.

These documents will be updated jointly by correspondence.

3. The results of the MWG during 2018- early 2019

Presentations were given by MWG members as planned in following meetings:

- Reporting to HELCOM MARITIME 18/2017 (November 2018 in Hamburg, Germany)
- Reporting to EUSBSR PA SAFE Steering Committee meeting (EU Strategy of the Baltic Sea Region, 9 May 2019) In Helsinki Stockholm ferry, Finland Sweden.

<u>BSHC22 task 14</u>: All MS to carry out hydrographic surveys and update HELCOM resurvey database. Poland and Kaliningrad Oblast to evaluate the possibility to upgrade the priority shipping routes with the help of commercial SOLAS shipping AIS data.

Chair has brought the item up in presentations at HELCOM MARITIME 18 and at EU SBSR PA Safe meeting. LT is progressing with the enlarged Cat II areas. PL has reviewed the Cat I and II routes and proposes a traffic separation scheme along the coast (Slupska Bank) and also a recommended track. No new information from RU.

Some samples of AIS statistical data from SMA [SE] is in waiting in order to analyze the SOLAS traffic in the South-East corner of the Baltic Sea.

4. Future Work of the MWG

MWG will continue to monitor the progress of the HELCOM Re-survey Scheme and follow Re-Survey Database development. It is of importance to have the database and interface operate reliably.

MWG asks guidance from BSHC24 on HELCOM Re-Survey Scheme continuation and proposes two alternative actions (see item C.1.2):

- a. continue, as the current Re-Survey Scheme is;
- b. Update the Re-Survey Scheme to include Cat III areas (area and timetable wise);

Continue cooperation with STM-FAMOS project (EU CEF program, TEN-T) concerning Re-Surveys in the Baltic Sea.

Follow up HELCOM Head of Delegates outcome item 6.57 on the need of updating Resurvey plan and perform Re-surveys especially in areas in South-Eastern Baltic, where AIS-records show commercial shipping taking place and which areas are not nationally



categorized as HELCOM cat I or cat II areas. HELCOM MARITIME Safe Nav 9 meeting item 6.1 on 7 Sept 2018 in Copenhagen, Denmark.

Continue cooperation and information exchange with NSHC.

Continue communication with relevant organisations and inform users by giving presentations and participating in relevant conferences, such as HELCOM Maritime and EU BSRS PA Safe Steering Committee (as having a Flagship status within EU). HELCOM SAFE NAV 10 meeting will be held in Copenhagen on 7 Sept 2019 and HELCOM MARITIME 19 will be held at EMSA in Lisbon 24-26 Sept, 2019.

To activate all the member states to send representatives to MWG meetings and participate MWG work.

The MWG has it's next meeting in Gdansk, back-to-back with BSHC24, on 10.9.2019 commencing at 10:00.

5. Actions for the BSHC 24th Conference

The BSHC 24th Conference is requested to

- 1. note this Report
- 2. approve the HELCOM Re-Survey Scheme assessment report to be presented to HELCOM Maritime 19;
- 3. Decide on the continuation of the HELCOM Re-Survey Scheme, to be presented to HELCOM Maritime 19 (see item C.1.2):
 - a. Continue work as for now. The Cat I & II areas to be estimated to be completed by 2030;
 - b. Mandate MWG to update the HELCOM Re-Survey Scheme to include the Cat III areas and to estimate a timetable for the work;
- 4. endorse the MWH regional discussion group stand on the IHO S-44 HSPT ed 6 draft. (see item C.1.3)
- 5. encourage member states to study and define Cat I & II areas in their waters based on the existing AIS-information on commercial shipping
- 6. encourage member states to perform re-surveys in areas of commercial shipping
- 7. encourage member states to participate actively to MWG work
- 8. give further guidance to MWG, as seen appropriate


