***For your consideration:***

- 1. assessment of the CB progress made by EAtHC to date, against the IHO CB Strategy and CB Work Program performance indicators;***
- 2. maintenance of the agreed EAtHC CB Plan;***
- 3. consider to held hydrographic trainings courses in venues where data update are needed and take the opportunity to conduct the practical activities to get the required data;***
- 4. refine the action plan (against the IHO CB Strategy and CB Work Program performance indicators again) and in accordance with Member States priority requirements;***
- 5. prepare a job description for a consultant to address CB issues; and prepare technical specifications for a master plan for the Region;***
- 6. if this Strategy is approved by EAtHC Member States, a proposed roadmap for the implementation of this new Strategy to be drafted by MACHC/EAtHC CB Coordinators to be submitted for consideration by the CBSC.***
