### 1. 11th Meeting of HCA

The 11<sup>th</sup> Meeting of the Hydrographic Commission on Antarctica (HCA) will be hosted by the Australian Hydrographic Service (AHS) in Hobart, Tasmania, Australia, on 5-7 October 2011.
