Antigua & Barbuda is an associated member of Meso-America and Caribbean Sea Hydrographic Commission (MACHC). A National Hydrographic Office (NHO) was established within the framework and standards provided by the International Hydrographic Bureau (IHB). It operates under the auspices of The Department of Marine Services and Merchant Shipping (ADOMS) St. John's. ADOMS is the Maritime Administration of Antigua & Barbuda

2.1 Hydrographic Surveys

A diminutive survey was carried out by the Antigua and Barbuda Port Authority to ascertain the actual depth of the ST. John's Harbour which is due for sweeping at this time..

The scoping study for Antigua and Barbuda was done on 16th- 18th July 2014 and involved a consultative component, in the form of presentations and group discussion and dedicated one-on-one meetings with key Government Agencies : Environment Division, Survey Department St. John's Development Corporation, Antigua Port Authority, West Indies Oil Company, The Fisheries Div. National Parks Authority, Antigua & Barbuda Defense Force Coast Guard, Meteorological Services National Office of Disaster Services, Chief Town & Country Planner, Development and Planning Unit The Study was facilitated by The OECS Hydrographic Working Group (HWG)/consultation team comprised of Mr. Sam Harper, UKHO, Dr. Asha Singh, OECS, and Wayne Edmeade and Lt. Cdr. Wayne Mykoo.
