

<p>Introduction</p> <p>The purpose of IHO Publication C-55 is to provide base data for governments and supporting international organizations as they consider the best means by which to implement responsibilities set out in Chapter V, Regulation 9, of the Safety of Life at Sea (SOLAS) Convention. <p>Hydrography and Maritime Activities</p> <p>The significance of hydrographic effort to safe use of the sea, national economic prosperity, and protection of the marine environment is elaborated in IHO Publication M-2. That publication identifies three core capabilities, the status of which is assessed in the three sections of the C-55 data-base:</p> <p>A. Hydrographic Surveying. B. Nautical Charting. C.
