19th Meeting of Mediterranean and Black Seas Hydrographic Commission (MBSHC) Batumi / Georgia 30 June-02 July 2015

Final Summary Report

DAY 1: Tuesday, 30 June 2015

1. Opening and Administrative Arrangements

1.1 Opening Address (Chairman, IHB Director, Host)

The MBSHC Chair, M. Erhan Gezgin first addressed the floor, welcoming the participants of that 19th Conference of the Mediterranean and Black Sea Hydrographic Conference (MBSHC) and acknowledging Georgia for hosting this event, followed by a representative of the Ministry of sustainable development of Georgia and M. Aleksandre Dolbaia, Head of State Hydrographic Service of Georgia. Then M. Mustafa Iptes, IHB Director closed this opening address session with his speech, also thanking Georgia as host of that Conference.

The Host officially declared the 19th Conference of the MBSHC opened.

1.2 Administrative Arrangements

GE announced the cancelation of the visit initially scheduled strait after the Day#1 session. Instead, delegates will be transported to the theatre for the Group Photo after the Conference session.

The collection and examination of INT charts topic was discussed at the Region F ICCWG side-meeting on the one hand and while addressing the IRCC7 outcome (item 6.1) on the other hand. Regarding the establishment of the Crowed Sourced Bathymetry Working Group (CSBWG), the Terms of References were issued by Circular letter 42/2015 dated June 18th 2015. CSBWG inaugural meeting will take place in Kuala Lumpur, Malaysia during the week of GEBCO meetings from 5 to 9 October 2015.

Regarding the amendments on article 6 of the rules, the question of the true meaning of the phrase 'will cast a deciding vote' was raised by IHB as its translation into French of the expression 'will cast a deciding vote' could lead to some confusion. UK precised the true meaning of that expression in English, being that the MBSHC Chair vote will be the deciding vote.

On the other hand, the two thirds quorum condition of MBSHC Member States to cast a vote was maintained in the final version, for consistency with the quorum condition in the MBSHC Statutes pointed out by FR.

IHO Work Programme 1– "Corporate affairs"

4.1 Cooperation with International Organizations

IHB reported that DZ, AR and IN provided the Government of Monaco with their approval to the Protocol of Amendments to the Convention on the IHO, raising the total amount of approval up to 45 out of the 48 requested. In the MBSHC region, no responses from HR, EG, SY, TR and UA have been received yet.

Regarding new application for IHO Membership, LB announced their decision to apply, indicating the Lebanese Ministry of Foreign Affairs is in charge of conducting the process. IHB will conduct a high level visit to Lebanon in that perspective.

4.2 Cooperation with European Union - EU

<u>MBSHC19-4.2C</u> Proposal for consideration for implementing a common (DTM) Bathymetric Database under the auspices of MBSHC (Greece).

IHB congratulated the IENWG on the outcome of the EU call for tender on coastal mapping and more generally for the work achieved, beneficial for all the maritime community.

Concerning the proposal on a common DTM, TR raised the question of its resolution and its licence (open or commercial). According to FR, a common DTM has to be significantly funded by the European Community, even though it involves more coastal States than the European countries in the Mediterranean region. IHB added that if it is not done by HOs themselves, others will do it.

IHB indicated that data accessibility was raised at the last IRCC7 Conference, and the decision to include relevant national legislations aspects in IHO C-16 and C-17 publications as a step forward.

FR clarified the differences between national legislations and European directives, pointing out that the matter of national security may prevail in some cases.

TR suggested issuing an action for the next MBSHC Chair to disseminate a circular letter to the Member States asking for their views and positions on that topic.

IHB emphasized on the outcome of the 28th Session of the IOC Assembly that was held in Paris (18-24th June), more particularly the improvement of the GEBCO project governance.

4.5 Information Management (IHO Website, WMS, ENC Catalogue etc.) (IHB)

As an introduction, a first focus was made by the Region F ICC Co-ordinator on the tools used to monitor and assess the Regional NT chart scheme and the overlaps and gaps of the ENC coverage.

Then IHB gave an overview on the development of the forthcoming IHO management tools, such as the IHO GIS and the INToGIS project. IHB indicated the transfer of the $\,$ S-11 publication part B into the IHO GIS on January $\,$ 1st $\,$ 2016, which will encompass either 'produced' or 'schemed' charts. In a further step of that project, the ENC catalogue and main maritime routes will also be integrated to the GIS database.

FR asked IHB if they intent to gather information from the different sources mentioned in the Region F ICC Coordinator's presentation (<u>MBSHC19-4.5A)</u>. IHB confirmed their intention is to do so, as decided at the IRCC7 Conference.

Region F International Chart Coordination Working Group (ICCWG) Side Meeting

During this side-meeting, discussions focused on proposals related to the regional INT chart scheme. GR presented their cartographic boundary approach as a potential technical way forward to co-production agreement between GR and TR in the Aegean Sea. The ICCWG welcomed the efforts made by GR to provide the ICCWG with this new approach, and suggested to take the technical discussions on to a bilateral level by setting up a first bilateral meeting by the end of 2015 (action MBSHC19/16).

ICCWG Members agreed on the dissemination of all the decisions made by the Region F ICCWG through a dedicated circular letter to the ICCWG Members (action MBSHC19/17), according the Region F ICCWG Terms of Reference.

The main outcomes of those discussions are stated in the Region F ICCWG report on INT chart that was presented on Day#3 (item 6.4).

Region F ICCWG Side Meeting (continuation of Day#1 side-meeting)

In continuation of the Day#1 side-meeting, and according to the Region F ICCWG side-meeting agenda the discussions focused on the ENC UB1 and UB2 coverage. One of the reasons of the absence of agreed ENC scheme in that region remains the lack of progress on the resolution of UB1 overlapping cases and leading to a disparate UB1 scheme in contradiction with a well-established small scale INT charts scheme covering the region. Besides, the persistency of some UB1 scheme overlapping cases and the significant domino effect associated with the solving of UB2 overlapping cases prevented the ICCWG from properly addressing the

UB2 scheme. However, the proposal of focusing on larger scale usage bands, such as UB4-5-6, was then discussed as an alternative in order to move forward on the approval of ENC schemes in the region. The outcomes of those discussions are stated in the Region F ICCWG report on ENc coverage presented on Day#3 (item 6.4).

FR indicated that the "exclusive right" should be understood as "responsibility", as nothing prevents two neighbouring nations to set a mutual agreement to adapt their share of responsibilities, as it' been done between US and CA recently.

IHB reminded that the guidance for the establishment of ENC production boundaries is gathered in the annex to circular letter 1/1997. Regarding to the concept of cartographic boundary, which is closely embedded to that approach, it is clearly explicated in the circular letter 40/2014 dated May 26th 2014 about the revision of the Guidelines for the implementation of the WEND Principles.

ANNEX: RULES FOR THE SELECTION OF MEMBER STATES FROM MBSHC TO THE IHO COUNCIL

(as approved at the XIXth MBSHC Conference)⁴

Selection from MBSHC to the IHO Council shall be determined in compliance with IHO General Regulations Art.2 and Art.16.

- 1. MBSHC Member States who wish to be selected from another Regional Hydrographic Commission (RHC) shall inform the MBSHC Chair and the IHO Secretary-General six months before the ordinary session of the IHO Assembly.
- 2. Member States who wish to be selected from MBSHC to the Council shall submit their application to the Chair and the IHO Secretary-General six months before the ordinary session of the IHO Assembly.
- 3. If the number of candidates is equal to the number of seats allocated for MBSHC by the IHO Secretary-General, then the aforementioned candidates will be automatically selected.
- 4. If the number of candidates is less than the number of seats allocated, the candidates will be automatically selected. Remaining positions will be selected, under the supervision and follow up of MBSHC Chair, from a list of all MBSHC Member States in French alphabetical order, except for those States who are candidates of another RHC, giving preference firstly to the remaining States that have never been selected before, and secondly to those that have not been selected the longest time ago.
- 5. If the number of candidates is more than the number of seats allocated, a voting will take place at a Conference of the MBSHC, or by correspondence if no MBSHC Conference is scheduled in the six months prior to the IHO Assembly. Each Member State will submit one voting paper listing the Member States from the list of candidates equal to the number of seats allocated. The highest voted candidates will be selected from MBSHC. In case of a draw, the Chair will cast a deciding vote.
- 6. The Chair shall notify MBSHC Member States of the results.

7. In case the selected State is unable to carry out its duties, the aforementioned selection process will be repeated.

8. All expenses connected with the participation to the Council shall be defrayed by their respective States, in accordance with IHO General Regulations Art. 3.
