### 1. Opening.

- 1.1. The meeting was opened by Vice-Admiral Ahmed Khaled, Commander in Chief of Egyptian Navy, in the presence of Dr Hesham Arafat, Minister of Transportation, and Vice-Admiral Mohab Mamesh, Chairman of the Suez Canal Authority.
- 1.2. The Chair welcomed all the participants to the meeting and to Egypt in particular. He highlighted the importance of the contacts outside the formal sessions. He noted the short notice for the arrangements, which were due to external factors beyond the control of the Egyptian Navy Hydrographic Office (ENHO).
- 1.3. All participants introduced themselves, (Bangladesh, Egypt, France,India, Indonesia, Mauritius, Myanmar, Oman, Russian Federation, Saudi Arabia, Sri Lanka, Thailand, UK, USA, International Association of Marine Aids to Navigation and Lighthouse Authorities (IALA), Regional Organization for the Conservation of the Environment of the Red Sea and Gulf of Aden (PERSGA), CARIS, Fugro, IIC Technologies and Kongsberg Maritime).
- 1.4. <u>Administrative Arrangements</u>. The Chair provided administrative arrangements and details of the timings for the meeting. He highlighted the evening activities, which were designed to show some of the best of Egyptian culture. He hoped the meeting would conclude by midday on Thursday.
- 2. <u>Approval of the Agenda and 16<sup>th</sup> NIOHC Report</u>. The agenda and timetable were approved. IHO noted the correction required to the agenda to amend IHB to read IHO Secretariat. The Chair highlighted the list of documents currently uploaded to the NIOHC17 page. The 16<sup>th</sup> NIOHC Meeting report was also approved.
- 3. <u>16<sup>th</sup> NIOHC-List of Actions.</u> The meeting reviewed the List of Actions generated at the NIOHC16 meeting.
  - 3.1. Membership of IHO and NIOHC. IHO provided an update on the progress to encourage Jordan, Maldives and Sudan to become Associate members of the NIOHC and full membership of the IHO. IHO noted a high level visit had been conducted to the Seychelles and subsequently recent indications were that she would be completing the application in the near future. It was noted that an increase in membership of the NIOHC would increase the number of

council seats allocated to two. IHO indicated there were no indications that Jordan, Maldives and Sudan were progressing. BGD inquired which countries had been invited to the meeting; the Chair indicated that invitations had been issued without response. IND noted there were political and economic issues which impact on these countries. UK noted that engaging with the countries remains a challenge. The Chair noted that this action remains and should be continued. UK noted Jordan would be attending the MSI course in Cape Town in September and the IHO noted that dialogue had been commenced with NAVAREA IX Coordinator on the provision of MSI. IALA noted their technical visit to Jordan. IND noted that Maldives was aware of the importance of IHO activities and their SOLAS obligations as well as the impacts of climate change: it was important that NIOHC members engage with them and encourage participation in NIOHC and IHO meetings. IHO noted a high level visit had been conducted in 2015; however little impact and progress had been achieved. BGD highlighted the assistance being provided by IND, these countries note the requirement but take minimal action. UK noted that a technical visit had been paid to Seychelles; suggested the approach should be to encourage IHO membership. and would then be eligible for Associate membership of the NIOHC. Observer membership of the NIOHC and then membership of IHO before moving to full membership of the NIOHC. UK suggested IALA could assist during their Technical Missions to encourage IHO membership and in fact joint Technical visits could be conducted. The Chair moved the current action to NIOHC17 List of Actions

3.2. <u>Participation in IHO Meetings</u>. IHO noted that none of the NIOHC members attended the IRCC, HSSC, WEND-WG and MSDIWG meetings, all were encouraged to engage with these WGs.

3.3. It was agreed the majority of outstanding actions were covered in later agenda items. The status of the List of Actions was approved.

### 4. Participation/Membership of NIOHC.

4.1. <u>Indonesia.</u> The Chair noted the application of IDN to become an Associate member; he highlighted the terms and requirements of the current statutes. BGD supported the application, whilst IND expressed caution. IHO supported the application as an expression of intent. UK noted the requirement to be within Region J to become a full member. IND noted that IDN should become

an Associate member; BGD supported the application for full membership; IHO indicated IDN could become a member of Region J and then a full member. UK highlighted that it was a requirement to be geographically located within the Region J area and therefore Associate membership was appropriate, which IND agreed to. IDN expressed a wish to become a full member due to their activities within the Indian Ocean. IHO noted that the current statutes were clear on membership qualification, also that the NIOHC could amend the statutes as they considered appropriate. IND considered it not appropriate to amend the statutes, which were issued by the IHO. IND proposed IDN to become an Associate. UK, BGD. EGY. THA, MMR and LKA supported the proposal and IDN was accepted as an Associate member of the NIOHC. IND noted that the only difference was the voting rights and welcomed IDN to the Commission. Information received after subsequent investigation indicated that Indonesia did in fact have territory within INT Chart Region J and therefore could become a full member of the NIOHC. The Chair invited the NIOHC member states to reconsider the issue and it was agreed that IDN should be invited to become a full member.

### 5. IHO Matters.

5.1. IHO Report. IHO provided a comprehensive brief on IHO Secretariat activities; particularly focusing on the main changes which came into force as a result of the approval of the protocol of amendments to the IHO Convention. It was noted that joining the IHO had been made much simpler and it was hoped there would be applications from the large flag states as well as other coastal states, which would benefit from engagement with the Organization. The outcomes of the various technical visits undertaken were noted. The NIOHC participants were encouraged to engage with the Region J Coordinator to improve the coverage and quality of charting within the region. All were

requested to provide updates to C-55 and P-5 on at least an annual basis. Outreach activities were highlighted including WHD events conducted by NIOHC states, the theme for 2017 was highlighted and the considerations behind it to encourage the availability of more data. Provision of articles covering technical and related activities and events were welcome for submission to the IHR. IHO suggested a change to the current nomination to the editorial board as the present representative had retired from his activities with SAU, IND recommended a formal process. It was agreed the nomination should take place later in the meeting. IND noted a number of articles had been discussed but as yet, had not been submitted. CB activities were highlighted and the quantity of activities taking place in the region and amount of NIOHC states that were benefiting from CB programmes and training courses was noted. It was noted that a new CB plan would be developed later in the meeting. Other activities were highlighted, particularly activities to increase available funds to support additional training and programmes.

5.2. <u>IHR Representative</u>. Noting that the current nominated IHR representative had retired from his position at GCS in SAU, IND agreed to investigate a potential volunteer from within the IND Hydrographic Service and report by 27 September.

5.3. Report to IRCC9. Chair noted that the report had been presented to IRCC9 by the UK. He quickly highlighted the main items in the report. IHO highlighted the activities and increased engagement with other international bodies including IMO, WMO, IOC of UNESCO, ISA, IALA and various UN and regional bodies, with a number of which MOUs have been signed. Also highlighted were the increased number of official Observer organizations now participating in IHO programmes and activities.

### 5.4. Reports on IRCC8 and IRCC9.

- 5.4.1. IRCC8. IHO provided a brief summary of the outcomes of the IRCC8 meeting, held in Abu Dhabi in May 2016, highlighting the items relevant to the NIOHC. IHO gave a comprehensive brief on the outcomes of the A-1. IND asked whether the procedure for electing the Chair and Vice-Chair of Council should be left to the RHC representative or a collective decision for the RHC. It was agreed that it was each Council representative to vote as they considered appropriate.
- 5.4.2. IRCC9. IHO then provided a summary of the main outcomes of the IRCC9 held in Paramaribo, Suriname, in June 2017. It was noted that the final report and list of actions would be published soon. Resultant actions from the IRCC9 meeting were covered in detail and relevant items were highlighted to the participants for consideration and action as appropriate.
  - 5.4.2.1. Improvement in MSI flow to NAVAREA Coordinators.

- 5.4.2.2. Support of CB initiatives and provision of resources for expansion of CB activities were highlighted.
- 5.4.2.3. All were encouraged to make their ENCs available and distributed through a RENC.
- 5.4.2.4. NIOHC encouraged nominating a regional RHC MSDI Ambassador to promote the establishment of national MSDI's as part of the national SDI management.
- 5.4.2.5. RHC member states were encouraged to review national legislation to allow CSB actions to take place within their areas of national jurisdiction and to encourage the gathering of data as well as the release of data currently held in national databases, as a subset if necessary.
- 5.4.2.6. NIOHC states were encouraged to review the CSB draft guidance document and provide comment and input to prepare the Edition 1.0.0 for approval by all IHO member states.
- 5.4.2.7. NIOHC states were encouraged to provide shallow water data to GEBCO to improve the bathymetric grids, particularly in the near shore and coastal areas.
- 5.4.2.8. It was agreed for NIOHC states to investigate volunteers for the role of RHC MSDI Ambassador and discuss at the next meeting.
- 5.4.2.9. All MS are to note that further details will be available from the IRCC9 page of the IHO website in due course.

### 9. Capacity Building.

- 9.1 The Regional CB Coordinator provided an introductory brief on the background to the IHO CB programme and the manner in which the NIOHC has benefitted from courses and activities. The Regional CB Coordinator highlighted some of the changes which have come into force as a result of the revision of the CB Strategy, in particular non-IHO member states will, in the future, only be able to participate in Phase 1 activities; he also noted that being or becoming an IHO member state does not mean that Phase 1 has been achieved.
- 9.2 The Regional CB Coordinator provided a review of activities over the past year, 2016 and those planned or conducted in 2017.
- 9.3 The Regional CB Coordinator then highlighted the activities approved and funded for 2018. He then proposed activities for 2019, which could be submitted to the CBSC16 meeting. He requested all NIOHC states consider what activities were required and to advise him so a comprehensive bid can be generated in preparation for CBSC16. The other training opportunities available through international organizations and NIOHC states were highlighted. He noted the new procedures recently agreed, which are designed to help the CBSC to prioritise bids, particularly when there are a large number of applications. FRA explained the creation and development of the MSI e-learning package and the anticipated methodology, it was noted that experienced qualified trainers are still required.
- 9.4 BGD asked whether courses could be conducted within the region rather than requiring extended travel. IND explained the reasons for coordination through the chairs of the RHCs to ensure best coordination of limited resources (funds and trainers).IHO explained the background to the planning of the MSI training course in South Africa.
- 9.5 BGD noted a requirement for MBES data processing; the Chair suggested this request to be included in the coordinated NIOHC bid.
- 9.6 BGD proposed that the hosting of the NIOHC be arranged and confirmed 3 years ahead. BGD suggested appointing a second Vice-Chair so that the succession line would be confirmed and known. IND noted that the Chair or Vice-Chair hosting the meeting was not a requirement and that the automatic succession had recently been agreed and any further change would require amendment of the statutes.

- 9.7 EGY inquired how their newly recognised S-5 (hydro survey) Cat B programme can be included in the IHO CB plan. The Regional CB Coordinator suggested contacting the IHO Secretariat for the issue of an IHO Circular Letter advertising the course, he noted that funding and student support needed to be confirmed. IHO indicated that details need to be provided about 3 months before the CBSC with long term plans for the availability of the course in the future.
- 9.8 The Regional CB Coordinator highlighted that CB was not limited to the activities funded by the CBSC, he highlighted the activities undertaken by other states such as IND and UK.
- 9.9 CB Coordinator to circulate a letter by 27 July requesting bids from NIOHC members and Associate members for CB activities to be submitted to CBSC16.

- 10.1 <u>International Aids to Navigation and Association of Lighthouse</u> <u>Authorities</u>. IALA gave a presentation covering its history, current activities and future change of structure to become an IGO.
- 10.2 <u>PERSGA</u>. Regional Organization for the Conservation of the Environment of the Red Sea and the Gulf of Aden (PERSGA) gave a presentation on its structure and current activities.
- 10.3 <u>GEBCO</u>. IHO provided a brief on GEBCO activities. NIOHC states were encouraged to make data and shallow water bathymetry available to improve the gridded data and the coverage of the world bathymetry. IHO also highlighted that the position of Seabed 2030 Project Director had recently been advertised through the GEBCO website.

### 11. MSI and NAVAREA Report.

- 11.1. IND, NAVAREA VIII Coordinator, provided an update brief on activities within the region. The lack of navigational warnings being provided by regional national coordinators is low and a matter of concern
- IND noted that the provision of information as navigational warnings or for inclusion in nautical publications are published for the benefit of mariners. IHO provided additional data from IMO meetings, which included details on the next phase of work after the approval of the Modernization Plan for the GMDSS by the IMO MSC98. This included work on revision of definitions in SOLAS Chapters III and IV and the scope of Chapter IV. Work to develop a preliminary draft work plan for the related and consequential amendments to other existing instruments was generated. The draft work plan included a number of IMO resolutions, the most significant to the IHO were resolution MSC 191(79) -Performance Standards for the presentation of navigation-related information on shipborne navigational displays, resolution A.801(19) as amended by MSC 199(80) - Provision of radio services for the Global Maritime Distress and Safety System (GMDSS), Resolution A.707(17) - Charges for Distress, Urgency and Safety Messages through the Inmarsat System, Resolution MSC.306(87) -Revised performance standards for Enhanced Group Call (EGC) equipment, and Resolution MSC.68(68), Annex 3 - Performance Standards for MF/HF Radio Installations Capable of Voice Communication, Narrow Band Direct Printing and Digital Selective Calling - all of which impact on the work of a number of IHO committees, sub-committees and working groups. It is intended that the first draft revisions will be submitted to NCSR5 for further consideration.
- 11.3. IHO Member States are encouraged to engage with the future work of the Expert Group and the Correspondence Group.
- 11.4. The revision and review of the C-55 has highlighted a number of discrepancies between the MSI details provided for inclusion in C-55 and the updates provided to the IMO for inclusion in the GMDSS Master Plan Annex 7 and 8. It is likely that this has been caused by different national authorities providing the data in answer to the same questions to the two organizations. Normally the HO provides the C-55 data and the Maritime Authority submits updates to the IMO for the GMDSS Master Plan, it is vital that there is coordination and harmonization for this data between national organizations, therefore, NIOHC states are requested to review their C-55 and GMDSS Master Plan Annex 7 and 8 entries and harmonize the information if necessary.

12. <u>Towards Data Centricity/e-Navigation</u>. UK provided a presentation focused on e-Navigation focusing on its importance to the mariner and future hydrographic products. IHO highlighted the activation of the IMO-IHO HGDM (Harmonization Group on Data Modelling) and its first meeting in 16-20 October at IMO in London; UK asked whether an IHO Circular letter would be issued with details and information on who should be participating, it was noted that IHO CL 43/2017 provided some details. The Chair encouraged all NIOHC states to consider participating in the meeting.

- 13. <u>Dealing with Maritime Disasters</u>. IHO provided an update on actions and related preparations undertaken by IHO Member States and in particular the NIOHC states in accordance with IHO resolution 1/2005. Examples of actions and support taken by RHCs in response to recent natural disasters were highlighted. FRA provided details of an incident in the south west Pacific where MV *Kea Trader* grounded SSW of Maré (îlesLoyauté) and required various actions in the salvage/recovery period, which included a bathymetric survey of the reef area to allow access.
- 14. <u>Crowd Sourced Bathymetry (CSB)</u>. IHO provided an update on the activities of the CSBWG and the development of the Guidance Document. NIOHC states were requested to review their national legislation to see whether the collection and publication into the public domain of CSB was acceptable. NIOHC states were encouraged to provide comment and feedback on the draft Guidance Document, once circulated by IRCC.

15. <u>Satellite Derived Bathymetry (SDB)</u>. UK provided a presentation on SDB, giving background details on the technology and examples of results achieved. In addition, potential cartographic representations were provided along with examples of BA charts published using SDB. This generated much discussion and numerous questions. It was noted that standards applicable to SDB data were one of the considerations being addressed by the HSSC HSPT (IHO Project Team on Standards for Hydrographic Surveys) as they undertake the review of IHO publication S-44 – IHO Standards for Hydrographic Surveys.

16. <u>Industry Presentations</u>. Presentations were provided by IIC Technologies, CARIS, Sonardyne and Fugro; these generated numerous questions and comments.

### 17. Any Other Business.

- 17.1. IHO highlighted the 'Inventory of National Tide Gauges and Current Meters' and the 'Actual Tides and Currents On-line Links', which can be found on the TWCWG page of the IHO website. All NIOHC states were encouraged to provide details of their tide gauges and currents and links to their real-time online tides and currents websites for inclusion in the lists.
- 17.2. Report to IRCC10. The Chair noted he would be generating the NIOHC report to IRCC10, which will be held in Goa, India, 4-6 June 2018. The Chair asked if there were any particular issues and topics which NIOHC states wished to have included in the Chair report, input should be received by the Chair before 30 March 2018.
- 17.3. IND encouraged all NIOHC states to consider hosting IRCC subordinate body meetings as well as attending.
- 17.4. IHO highlighted that CBSC16 will take place in Goa, India, 30 May to 1 June 2018.

He thanked the sponsors for their support and the assistance in organizing the meeting, he also thanked all those who had been part of the organizing committee and the hard work to ensure the success of the event. He wished all a safe journey home. The IHO highlighted the success of the meeting, which was in no small part down to the preparations and efforts of the Chair and all those who supported him at the Egyptian Hydrographic Service. The NIOHC flag was passed to the next Chair.
