Dear colleague,

In my letter 2015001947 of 30 April, I requested your input on five questions related to the future of the Dover Straight Survey Strategy Working Group (DSSSWG) in relation to the NSHC Resurvey Working Group (RWG). This followed from Conclusion 111 of the 2014 NSHC Conference. Thank you for your reply. I collected all replies in the annexed Table.

Based on your answer, I conclude that we all are in favour of merging the BE/FR/NL/UK DSSSWG with the NSHC RWG, and that at least three of us wish to pursue a new Dover Straight Survey Strategy Agreement (FR has not expressed its opinion), to be managed by the NSHC RWG.

As a consequence of your input and as tasked by NSHC, I disband the DSSSWG, and would like to express my sincere appreciation for the work that this group has done over the years. Also, I give the NSHC RWG the action to update the Agreement, building upon the work that has already been done since the last DSSSWG meeting in January 2011. This process could start during the fifth RWG meeting in September.

Your reactions included several productive suggestions for the future of the Agreement. They constitute a sound basis for further discussion within the NSHC RWG. As NL currently chairs both the NSHC and its Resurvey Working Group, I will monitor the progress of the group and will create ample opportunity during the next NSHC meeting in Dublin in June 2016 to discuss the new situation.
